OSHA 10-HOUR GENERAL INDUSTRY

\$179/person for the OSHA 10 General Industry class. All participants receive an OSHA 10-hour General Industry card and a certificate from Mid-State Safety with 1.0 CEUs and a comprehensive 10-hour OSHA manual compiled and edited by Frank D. Goodwin.

OSHA 30-HOUR GENERAL INDUSTRY

\$549.00 per person for the OSHA 30 General Industry class. All participants receive the OSHA 30-hour card, a 30-hour certificate with 3 CEUs from Mid-State Safety, a 10-hour OSHA manual and a flash drive with class materials compiled and edited by Frank D. Goodwin.

OSHA 10-HOUR CONSTRUCTION

CPR/AED/FIRST-AID

NFPA 70E ARC FLASH/ ELECTRICAL SAFETY

\$289/per person for the 8-hour NFPA°70E class, including 2021 standards updates. All participants receive the NFPA°70E card with

0.8 CEUs, and a comprehensive NFPA°70E Electrical Safety handbook. The class emphasizes electrical workplace safety, principles of electricity, Arc Flash and NFPA°70E 2021 standards as they relate to Lockout Tagout, Personal Protective Equipment, FR-rated clothing, and insulated tools. This class includes a section on first aid for the injured. What should you do until the paramedics arrive to help the victim?

LOCKOUT/TAGOUT CONTROLLING HAZARDOUS ENERGY

SCAFFOLDING or FALL PROTECTION SAFETY

INDUSTRIAL HYGIENE SYMPOSIUM

The class teaches how to identify health and safety problems in the workplace, including chemical, biological, physical, ergonomic, asbestos HAZMAT, workplace security and violence, drug issues, hearing conservation, and workplace ergonomics. The curriculum includes gender, sexual, and racial harassment along with fire safety and evacuation.

CONFINED SPACE SYMPOSIUM
